

## TAKE NOTICE

Please take notice that the Board of Supervisors of Chesterfield County, Virginia, at an adjourned meeting on Wednesday, August 28, 2019 at 6:00 p.m., in the County Public Meeting Room at the Chesterfield Administration Building, Rt. 10 and Lori Road, Chesterfield, Virginia, will hold a public hearing to consider the enactment, pursuant to §15.2-2400, *et. seq.*, Code of Virginia, 1950, as amended, and pursuant to §§2.1 and 2.4 of the Charter of Chesterfield County, Virginia, as amended, of an ordinance to amend the Chesterfield Towne Center – Southport Area Service District, which finances median landscaping and quality maintenance and which imposes certain taxes upon the owners of property located in the District, by extending the District’s sunset date to January 1, 2030.

A list of the owners of property located in the District, and the tax map parcel number of the parcels which they own, is set forth below. Landowners may appear at the public hearing and, if they wish, show cause against the proposed amendment. Copies of the ordinance, Map of the District, and Plan of the District are available for public viewing between 8:30 a.m. and 5:00 p.m., Monday through Friday, in the Chesterfield County Administrator’s Office. After the public hearing, appropriate changes or corrections may be made to the ordinance.

The hearing is held at a public facility designed to be accessible to persons with disabilities. Any persons with questions on the accessibility of the facility or need for reasonable accommodations should contact Janice Blakley, Clerk to the Board, at 748-1200. Persons needing interpreter services for the deaf must notify the Clerk to the Board no later than August 23, 2019.
