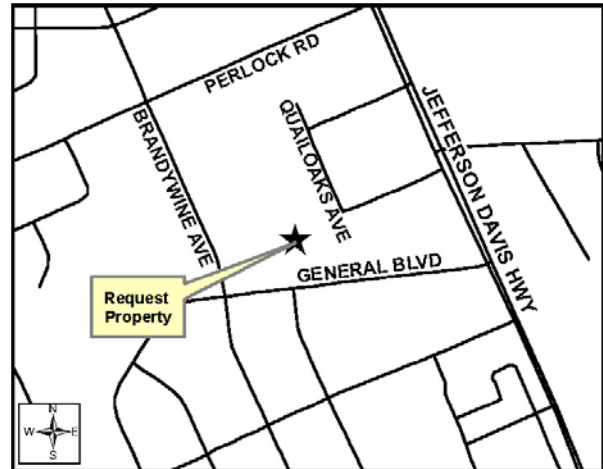

REQUEST

Conditional use to permit a farm in a Residential (R-7) District.

Note: Conditions may be imposed or the property owner may proffer conditions.

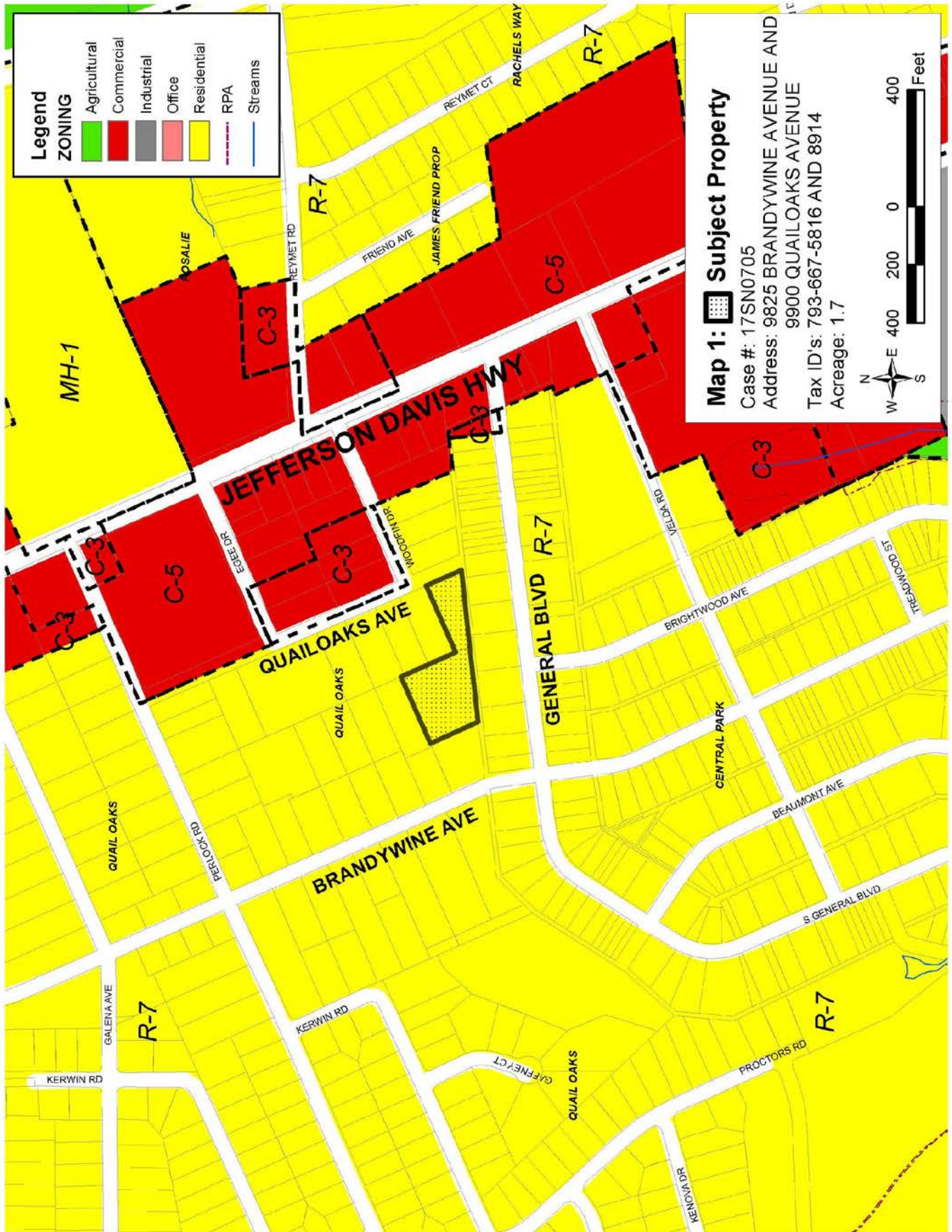
SUMMARY

Continued use of the property for a farm (the raising of donkeys and horses) is planned. The keeping of farm animals in Residential (R) districts requires conditional use approval.

DEFERRAL

The Bermuda District Commissioner has indicated his intent to defer this case to the Commission's regularly scheduled July 2021 meeting to allow additional time for the applicant to finalize the proposal. It would be necessary for the applicant to consent to a deferral longer than 100 days.

The deadline for the applicant to submit any new or revised information for a deferral to the Commission's regularly scheduled July 2021 meeting is June 7 2021. Staff supports a deferral to the Commission's regularly scheduled July 2021 meeting provided the applicant can meet this deadline for submitting additional information. Otherwise, a longer deferral would be appropriate.
