



REQUIRED ATTACHMENTS for PLANNING SIGN PERMIT APPLICATIONS

The following information **MUST BE ATTACHED** to allow timely review and approval for each proposed sign:

- For freestanding signs, site sketch or drawing showing location of freestanding sign; distance from right-of-way, edge of road pavement or face of curb; distance from adjacent property lines; and location of existing signs on the property and whether they advertise a commercial or noncommercial activity
- For freestanding signs, height of sign measured from ground elevation at which the sign is to be located
- For building mounted signs, sketch of building or tenant face and dimensions of the building or tenant face on which sign is to be located
- Sign elevations showing dimensions of sign face, type of anchoring, and sign message
- Other- If deemed necessary by the Planning Department, additional information to ensure compliance with the zoning ordinance.
